## **NOTICE**

Dear Members,

The Managing Committee takes no particular pleasure but nevertheless feels compelled to respond to certain false aspersions and malicious lies published illegally on an unauthorized Facebook Page in the name of The Catholic Club Chittagong by Expelled Member Mr. Richard Bryan Rebeiro.

The synopsis of our response is as follows:

1. Mr. Richard Bryan Rebeiro was duly Expelled from Membership of the Club for engaging in repeated and flagrant violations of the Club Constitution & By-laws, via a letter, after due Constitutional (Club) process with effect from 01<sup>st</sup> September, 2025.
2. The progression leading up to his expulsion is briefly,
  - a) Assault on a Member on 31<sup>st</sup> December, 2023 at the New Year's Ball.
  - b) Undressing and exposing his body parts in the presence of Members, Members spouses, children, local & overseas guests at the Annual Picnic, as well as acts conducive to creating a riot at the same, duly held on 10<sup>th</sup> January, 2025.
  - c) Bringing and consuming prohibited substances within the Club, even after repeated warnings to refrain from doing so on 31<sup>st</sup> August, 2025.
3. Repeated signed undertakings to refrain from such illegal acts was duly furnished to the Club Authorities by said expelled Member to no practical avail.
4. The allocation of two floors to the Club by the Archdiocese is based on two legally binding contracts signed between the Archdiocese and the Club, based on mutual understanding and respect.
5. As an Expelled Member, Mr. Rebeiro has no rights whatsoever (both legally & morally) to open a page on social media whilst using the Club name and logo, expressly aimed at spewing malicious propaganda meant to defame the Club.

6. Alcohol is available at select Club functions only after obtaining the requisite legal permission from the Narcotics & Liquor Control Board. Beyond the aforementioned legal process there is no scope to provide alcohol at Club functions.

7. Recreational activities at the Club are conducted within the spirit and parameters of the law. This has been in practice for over 107 years and needs no further explanation.

8. The authorized page of the Club is The Catholic Club Chittagong – Official FB Group and any other pseudo page or entity illegally purporting to use the Club name is highly fraudulent and downright illegal in nature. We request all concerned to kindly refrain from engaging in any transactions pertaining to the Club with Mr. Richard Bryan Rebeiro, or his fraudulent page.

In light of the above the Managing Committee fully comprehends that the activities of said Expelled Member, Mr. Rebeiro screams of the old adage of “Sour grapes” and go on to point out that his acts are highly illegal and malicious in nature.

Under said circumstances, if such acts do not cease then the Managing Committee will be compelled to pursue all lawful measures to protect the integrity of the Club.
